Comments : The product consists of Platinum heating equipments(100% platinum), Gold interdigitated electrodes(100% Gold (24 carat)), Silicon Base Plate (300 nm SiO₂ coating) and Si₃N₄ insulating layer (100% Si₃N₄ between gold and platinum electrodes).
